**FINANCIAL REPORT:** Becky Ylitalo, Houghton County Chief Financial Officer, presented the airport, water and sewer financials for September 2023.

PUBLIC COMMENTS: Kirk Hammel, Owner A+ Pest Company, expressed interest in selling back Outlot A located in the Airport Industrial Park to the County. Pursuant to the Airport Covenants the county has first right of refusal to buy the property back if the no improvements have been made. Mr. Hammel expansion plans have changed and he no longer needs the lot for expansion. He still has interest in building a Hangar without the office space. The Committee agreed to re-purchase the lot and tasked the Airport Manager with looking into what is required to purchase the lot.

#### **NEW BUSINESS:**

New Business, Agenda Item 1, "Century 21 Contract Amendment Lot 1". – The Airport Manager requested approval to sign the Century 21 Contract Amendment for Lot 1 which extends the term from 10/31/2023 to 10/31/2024. The current purchase price for the lot is \$99,800.00 for 23.14 acres. Commission is 7%.

**New Business Agenda Item 3, "Water/Sewage Report."** – For the period from September 13, 2023, to October 13, 2023 (30 days) daily I&I was 1,777 gallons. For the same time period in 2022, I&I was 4,777 gallons. For the period from September 13, 2023, to October 13, 2023 (30 days) water loss was (111,299) gallons. For the same time period in 2022 water loss was (123,060) gallons.

New Business Agenda Item 4, "Airline Monthly Statistics." – For the month of September 2023, SkyWest enplaned 2,223 passengers and deplaned 2,194. Last year in September SkyWest enplanements were 2,126 compared to this year's enplanements of 2,223 an increase of 97 passengers or 5%. SkyWest experienced 1 cancellation during the month compared to 1 in September of 2022.

**New Business, Agenda Item 5, "Sale of Loader".** – The Airport Manager requested permission to sell the 2008 JD 624K HL Loader to the Houghton County Road Commission. A discussion ensued and it was decided it would be more beneficial to retain the loader at the airport.
