NEW BUSINESS:

New Business, Agenda Item 1, "Water System Design and Construction Standards". – As part of the water and sewer ordinance Traverse Engineering has drafted "Design and Construction Standards" for the Water System. The airport manager requested a motion to approve the standards and incorporate them into the completed ordinances at a future date. If approved the standards will be used for any future projects.

New Business, Agenda Item 2, "Gooseneck Creek Dam Removal". – KRC in conjunction with EGLE is requesting permission to remove the Gooseneck Creek Dam located on County property. The dam removal and creek restoration would benefit the airport by eliminating a wildlife attractant, relieve pressure from the water and sewer system, and take away a liability to the county if the dam were to fail. The restoration would restore the creek to its original flow. EGLE would require the restored stream and wetland area to be placed under a conservation easement to ensure the stream is preserved.

New Business, Agenda Item 3, "2023 Michigan Airport Conference". – The airport manager requested permission to attend the 2023 MAAE Airport Conference February 14-17, 2023 in Lansing Michigan. The board members were also invited to attend. The conference is a budgeted item.

New Business, Agenda Item 5, "2023 Airport Committee Meeting Dates". – The Airport Manger requested approval of the Airport Committee Meeting dates for 2023.

New Business, Agenda Item 6, "Mead & Hunt Monthly Progress Report". – The Mead & Hunt progress report summarizing activities for the period from December 1, 2022, through December 31, 2022 was presented for review and discussion.

New Business Agenda Item 7, "Water/Sewage Report." – For the period from December 14, 2022, to January 12, 2023 (29 days) daily I&I was 6,875 gallons. For the same time period in 2022, I&I was 8,738 gallons. For the period from December 14, 2022, to January 12, 2023 (29 days) water loss was 124,257 gallons. For the same time period in 2022 water loss was 116,232 gallons.

New Business Agenda Item 8, "Airline Monthly Statistics." – For the month of December 2022, SkyWest enplaned 1,754 passengers and deplaned 1,634. Last year in December SkyWest enplanements were 1,953 compared to this year's enplanements of 1,754 a decrease of 201 passengers or 10%. SkyWest experienced 8 cancellations during the month compared to 6 in December of 2021.
