New Business Agenda Item 3, "Water/Sewage Report." - For the period from July 15, 2024, to August 15, 2024 (31 days) daily I&I was 754 gallons. For the same time period in 2023, I&I was 2,112 gallons. For the period from July 14, 2024, to August 15, 2024 (31 days) water loss was (130,864) gallons. For the same time period in 2023 water loss was (123,163) gallons.

New Business Agenda Item 4, "Airline Monthly Statistics." - For the month of July 2024, SkyWest enplaned 2,595 passengers and deplaned 2,663. Last year in July SkyWest enplanements were 2,391 compared to this year's enplanements of 2,595 an increase of 204 passengers or 9%. SkyWest experienced 1 cancellation during the month compared to 4 in July of 2023. Our completed flights load factor was 85%.
